Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that parcel or lot of land lying on the West side of Brockman Street, one mile West from the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being a portion of Lots Nos. 99 and 100 of the W.H. Brockman Estate as shown on Plat thereof by Dalton & Neves, Engineers, recorded in Plat Book "H", at page 132, R.M.C. Office for Greenville County, and particularly surveyed and platted as the property of Norval H. Floyd by H.S.
