I, Clyde Manley, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of - - - - Twenty-Five Hundred and No/100 - - - - - DOLLARS (\$ 2,500.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in School District 6-E, fronting on the northern side of Welcome Road, and having the following metes and bounds, to wit:

Beginning at a point on Welcome Road a distance of 34 feet east of the intersection of Welcome Road and New Cut Dunham Bridge Road, and running thence along Welcome Road S. 30-52 E. 100 feet to an iron pin at the western corner of Lot No. 21; thence along the western line of Lot No. 21, N. 60-00 E. 189.3 ft. to an iron pin at the rear corner of Lot No. 21; thence parallel to Welcome Road N. 30-52 W. 100 feet to a point; thence parallel to the western line of Lot No. 21, S. 60-00 W. 189.3 feet to the beginning corner on Welcome Road, and comprising the rear portions of Lots Nos. 22 and 23 and a part of the rear portion of Lot No. 24, as shown on plat of the J.
