BEGINNING at an iron pin on the Southeast side of Summit Drive, at joint front corner of Lots 3 and 4 of Block L, said pin being 114 feet in a Southwesterly direction from a point where the Southeast side of Summit Drive intersects with the South side of Reid Street, and running thence along the line of Lot 4, S. 23-20 E. 150 feet to an iron pin; thence S. 43-17 W. 75 feet to an iron pin; thence N. 23-20 W. 150 feet to an iron pin on the Southeast side of Summit Drive; thence with the Southeast side of Summit Drive, N. 43-17 E. 75 feet to the beginning corner.
