"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the East side of Chestnut Street, and being shown as lots Nos. 23 and 25, on plat of property of W. B. McDowell, recorded in Plat Book "S" at Page 53, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Chestnut Street, at the joint front corner of lots Nos. 21 and 23, and running thence with line of lot No. 21, N. 81-45 E. 202.5 feet to an iron pin; thence N. 13 W. 117.7 feet to an iron pin; thence S. 82-59 W. 150 feet to pin; thence S. 80-49 W. 40.4 feet to an iron pin on Chestnut Street; thence with the Eastern side of Chestnut Street, S. 8-15 E. 120.2 feet to the point of beginning."
