SEND GREETING:

Whereas, **I**, the said **Asalee H. Paris**
 in and by **my** certain **promissory** note in writing, of even date with these
 Presents, **am** well and truly indebted to **H.D. Harkey**
 in the full and just sum of **Twenty-eight hundred and no/100 (\$ 2800.00) Dollars**
 , to be paid
on demand

with interest thereon from **date**
 at the rate of **6** per centum per annum, to be computed and paid **annually**
 until paid in full: all interest not paid when due to bear
 interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid,
 the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
 may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
 hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
 necessary for the protection of his interests to place and the holder should place the said note or this mortgage
 in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
 to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
 the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

 , in hand well and truly paid by the said **H.D. Harkey**
 at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,
 sold and released, and by these Presents do grant, bargain, sell and release unto the said **H.D. Harkey, his**
heirs and assigns,

All that piece, parcel or lot of land in Greenville, Township,
 Greenville County, State of South Carolina, on McCall Street,
 between Brockman Avenue and the Perry Road, in the Sans Souci
 section of Greenville County, about two miles north of the
 City of Greenville, said lot having the following lines, courses
 and distances :-

BEGINNING at an iron pin on the northern edge of a sidewalk
 running along McCall Street, said pin being the joint corner
 of Lots numbered one(1) and two(2); thence along the eastern
 line of lot one (1), N.33-17 E. one hundred ten (110) feet,
 to an iron pin, joint rear corner of lots one (1) and two(2);
 thence along the southern line of lot five (5), S.56-48 E.
 sixty (60) feet, to an iron pin, joint rear corner of lots two
 (2) and three (3); thence along the western line of lot three
 (3), S. 33-17 W., one hundred ten (110) feet, to an iron pin,
 on the northern edge of a sidewalk running along McCall Street;
 joint front corner of lots two (2) and three(3); thence along
 the northern edge of said sidewalk, N.56-48 W., sixty(60) feet
