lying and being situate on the Southern side of Prancer Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot # 311, Pleasant Valley, according to plat of said sub-division prepared by Dalton & Neves in April, 1946, including additions to said Flat through November, 1948, as recorded in the R.M.C. Office, Greenville, South Carolina, in Plat Book "P", at Page 92; and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Prancer Avenue at joint front corner of Lots # 310 and # 311, said pin being 600 feet Northeast of iron pin in the Southeast corner of the intersection of Prancer Avenue with Panama Avenue; thence S. 0-08 E. 160 feet to an iron pin at joint rear corner of Lots # 310 and # 311; thence N. 89-52 E. 60 feet to an iron pin at joint rear corner of Lots # 311 and # 312; thence N. 0-08 W. 160 feet to an iron pin at joint front corner of Lots # 311 and # 312 on the Southern side of Prancer Avenue; thence along said Avenue, S. 89-52 W. 60 feet to iron pin at joint front corner of Lots # 310 and # 311, the point of beginning.
