"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Ware Street, in the City of Greenville, being a portion of lots Nos. 3, 4 and 5 shown on plat of the bankrupt property of W. H. Irwine, made by R. E. Dalton, Engineer, July 1916, recorded in the Office of the R.M.C. for Greenville County in Plat Book E at Page 284, and described as follows:
