Selma W. Coleman, L. Elizabeth Coleman and Mozelle C. Kennedy

hereinafter spoken of as the Mortgagor send greeting.

Whereas Selma W. Coleman, L. Elizabeth Coleman and Mozelle C. Kennedy

is justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of Eighteen Hundred and No/100 - - - - - Dollars

(\$1800.00 - - - - -), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by that one certain bond or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of

Eighteen Hundred and No/100 - - - - - Dollars (\$ 1800.00 - - - - -)

with interest thereon from the date hereof at the rate of 4 1/2% per centum per annum, said interest to be paid on the first day of August 19 49 and thereafter said interest and principal sum to be paid in installments as follows: Beginning on the first day of September 1949, and on the first day of each month thereafter the sum of \$ 22.37 to be applied on the interest and principal of said note, said payments to continue up to and including the first day of July 1957 and the balance of said principal sum to be due and payable on the first day of August 19 57 the aforesaid monthly payments of \$ 22.37 each are to be applied first to interest at the rate

of 4 1/2% per centum per annum on the principal sum of \$ 1800.00 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

on the Northwest side of Waccamaw Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot #49 and the adjoining one-half of Lot #50 on plat of Augusta Circle, made by R. E. Dalton, Engineer, November 1921, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book F, pages 22 and 23, said lot fronting 75 feet on the Northwest side of Waccamaw Avenue, with a depth of 166.36 feet on the Northeast side, a depth of 166.36 feet on the Southwest side of said lot along Winyah Street and being 75 feet across the rear.
