# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

KNOX-CAROLINA HOMES, a corporation chartered under laws of the State of South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto the

AIKEN LOAN & SECURITY COMPANY

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Seven Thousand Two Hundred Dollars (\$ 7,200.00 ), with interest from date at the rate of four and one-half per centum ( 4 1/2 %) per annum until paid, said principal and interest being payable at the office of Aiken Loan and Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Forty-Five and 56/100 ----- Dollars (\$ 45.56 ). commencing on the first day of October, 1949, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of September, 1958.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being near the corner of Collinson Road in the County of Greenville, State of South Carolina, on the northern side of Collinson Road in a subdivision known as Sylvan Hills, being known and designated as Lots 10, 11 and 13, and being described according to a map prepared by the Engineering Service, Greenville, South Carolina, and entitled "Sylvan Hills, near Greenville, S.C." and filed in the REC Office for Greenville County, S.C. in File No. 103. The mortgaged premises have, according to said map, the following metes and bounds, corners and distances, to-wit:

BEGINNING at an iron pin on the northern side of Collinson Road at the joint front corner of Lots Nos. 12 and 14; thence along the common line of said Lots Nos. 12-14 N. 70 degrees 30' E. 100 feet to an iron pin; thence N. 84-84 E. 70 feet to an iron pin at the rear corner of Lots Nos. 11 and 13; thence along the common line of said Lots Nos. 11-13 N. 70 degrees 30' E. 100 feet to an iron pin on the northern side of Collinson Road; thence along the northern side of Collinson Road S. 84-84 W. 70 feet to an iron pin, the beginning corner.

The above described lot is the property of the Mortgagor hereinafter J. Milton Williams, Sr. and is hereby by deed to be recorded.

Also included as part of the mortgaged premises are the following easily removable real estate items:

- 30 Gal. Electric Water Heater;      1/2" Attic Fan (10 blades)
- Floor Furnace;                              10" Kitchen Fan (10 blades)
- 1 K-W Wall Heater.
