# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

KNOX-CAROLINA HOMES, a corporation chartered under the laws of State of South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto the

AIKEN LOAN & SECURITY COMPANY, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Seven Thousand Two Hundred Dollars (\$ 7,200.00 ), with interest from date at the rate of Four and one-half per centum ( 4½%) per annum until paid, said principal and interest being payable at the office of Aiken Loan and Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of - Forty-Five & 56/100 ----- Dollars (\$ 45.56 ), commencing on the first day of October, 19 49, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of September, 19 50.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel of lot of land, with improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the Northern side of Jollinson Road in a Subdivision known as Sylvan Hills, being known and designated as Lot No. 14, of said subdivision and being described according to a plat prepared by the Piedmont Engineering Service, Greenville, South Carolina, dated June 1948, entitled "Sylvan Hills, near Greenville, S. C." and recorded in the REC Office for Greenville County, S. C., in Plat Book "S" at page 103, the mortgaged premises have, according to said plat, the following metes and bounds, courses and distances to-wit:

BEGINNING at an iron pin on the Northern side of Jollinson Road at the joint front corner of Lots Nos. 14 and 15 and running thence along the common line of said lots N. 3-33 W. 100 feet to an iron pin; thence N. 34-24 E. 70 feet to an iron pin, the joint rear corner of Lots Nos. 13 and 14; thence along the common line of Lots Nos. 13 and 14 S. 3-33 E. 100 feet to an iron pin on the Northern side of Jollinson Road; thence along the Northern side of Jollinson Road S. 34-24 W. 70 feet to an iron pin, the beginning corner.

The above described lot is one of the lots owned by the mortgagor herein by J. Milton Williams, Jr. and Stark W. Jollinson by deed to be recorded.
