"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township,

about four miles North from Greer, on the West side of the road leading from the State Highway No. 14 at Mosteller's Mill to the Washington Church-Oneal Road, containing Six and 47/100 (6.47) Acres, more or less, bounded by lands of D.L. Ray, Sloan and others, and having the following courses and distances, to wit:
