C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor in hand well and truly paid by the said mortgagee, at and Dollars to before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot #18, Block F, according to plat recorded in R.M.C. Office for Greenville County in Plat Book F, pages 131 and 132, and being on the South side of East Faris Road, having the following metes and bounds, to wit:-BEGINNING at a point on East Feris Road, joint corner of Lots 17 and 18 and running thence with said road N 63-35 E 60 feet to joint corner of Lots 18 and 19; thence with joint line of Lots 18 and 19 S 25-51 E 160 feet, more or less, to joint rear corner of Lots Nos. 4-5-18 and 19; thence with rear joint line of Lots 4 and 18 8 63-35 W 60 feet to rear joint corner of Lots Nos. 3-4-17 and 18; thence with joint line of Lots 17 and 18 N 25-51 W 160 feet, more or less, to the beginning corner. And do hereby bind myself and my Heirs, Executors, and Administrators to warrant and forever defend all and singular the said Premises unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns, from and against Heirs, Executors, Administrators and assigns, and every person whomsoever lawfully claiming the same, or any part thereof.
