C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor. in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being near the City of Greenville, on the Northern side of Dove Lane in ${f e}$ sub-division known as Super Highway Home Sites, being known and designated as Lot No. 165 and the Eastern half of Lot No. 164 of said sub-division, and being described according to a plat of Super Highway Home Sites, prepared by Dalton & Neves, Engineers, May 1946 and recorded in R.M.C. Office for Greenville County in Plat Book "P", page 53 and having the following courses and distances, to wit:-

BEGINNING at iron pin on the Northern side of Dove Lane at the joint front corner of Lots Nos. 165 and 166 and runs thence slong the common line of said lots N 20-10 W 168.5 feet to iron pin on the Southern side of Warehouse Court; thence along the Southern side of Warehouse Court S 74-17 W 78.2 feet to iron pin, the joint rear corner of Lots Nos. 164 and 165; thence continuing along the Southern side of Warehouse Court S 74-17 W 39.1 feet to a point; thence S 20-10 E 177 feet, more or less, to a point on the Northern side of Dove Lane; thence along the Northern side of Dove Lane N 69-50 E 39 feet to iron pin, the joint front corner of Lots Nos. 164 and 165; thence continuing along the Northern side of Dove Lane

N 69-50 E 78 feet to iron pin, the beginning corner. The above described property is subject to the restrictive covenants applicable to Super Highway Home Sites, recorded in Deed Vol 291, page 369, and subject to such rights of way and easements as may appear of record.
