all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina.

including the buildings and improvements thereon situate, lying and being situate on the Northern side of Prancer Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot # 266, Pleasant Valley, according to plat of said sub-division prepared by Dalton & Neves in April, 1946, including additions to said Plat through November, 1948, as recorded in the R.M.C. Office, Greenville, South Carolina, in Plat Book "P", at Page 92, and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Prancer Avenue at joint front corner of Lots # 265 and # 266, said pin being 840 feet Northeast of iron pin in the Northeast corner of the intersection of Prancer Avenue with Panama Avenue; thence N. 0-08 W. 160 feet to an iron pin at joint rear corner of Lots # 265 and # 266; thence S. 89-52 W. 60 feet to an iron pin at joint rear corner of Lots # 266 and # 267; thence S. 0-08 E. 160 feet to an iron pin at joint front corner of Lots # 266 and # 267 on the Northern side of Prancer Avenue; thence along said Avenue, N. 89-52 E. 60 feet to iron pin at joint front corner of Lots # 265 and # 266, the point of beginning.
