SEND GREETING:

Whereas, I, the said G.F. Stewart
do hereby certify certain promissory note in writing, of even date with these
as well and truly indebted to The Peoples National Bank,
Greenville, S.C.
in the full and just sum of Three Hundred and no/100 (\$300.00)

to be paid \$25.00 quarterly, plus interest, the first
payment being on December 2, 1949, and on the 2d day of each quart-
erly period until paid in full

with interest thereon from date

at the rate of 6% per centum per annum, to be computed and paid monthly

until paid in full: all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said The Peoples
National Bank, Greenville, S.C., its heirs and assigns,

All that piece, parcel and lot of land, with improvements thereon,
situate on the East side of Second Avenue (now Otis Street), near
the City of Greenville, in the County of Greenville, State of
South Carolina, being known and designated as Lot # 12, of Block
"G", on plat of Park Place, recorded in RMC Office for Greenville
County, in Plat Book "A", Page 119, said lot having a frontage on
the East side of Second Avenue (Now Otis Street), of 50 feet and
running back in parallel lines a depth of 110 feet.

This is the same lot conveyed to Carrie V. Hitt, by deed from Furman
University, as Trustee under the will of Lillie Hawthorne, Deceased,
said deed being dated 26 August 1941, and deed being recorded in
RMC Office for Greenville County, in Deed Book 236, Page 360.

The said deed from Furman University, as Trustee under the will of
Lillie Hawthorne, deceased, to Carrie V. Hitt, describes said lot
as having a frontage of the East side of Second Avenue of 50 Feet,
and running back in parallel lines a depth of 150 feet to a 10
