"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, being know and designated as Lot No. 2 on the Plat of the Property of Lucia Dalton Newton, made by Dalton & Neves and recorded in Plat Book U at Page 41, and having, according to said Plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of U. S. Highway No. 29 at the joint front corner of Lots Nos. 3 and 2, and running thence with the right-of-way of U. S. Highway No. 29, N. 31-45 E. 100 feet to an iron pin at corner of Lot No. 1; thence with the line of Lot No. 1, S. 66 E. 219.4 feet to iron pin on right-of-way of P & N Railway; thence with the line of said right-of-way, S. 27-52 W. 99.3 feet to iron pin at rear corner of Lot No. 3; thence with the line of Lot No. 3, N. 66 W. 226.2 feet to the point of beginning."
