in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. E. Robinson, as Trustee under the B. M. McGee Will, his successors and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the east side of Henderson Street, and being known and designated as all of Lot No. 54 and the northern one-half of Lot No. 53, of a subdivision known as City View as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book A, at page 460, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Henderson Street in the center of the front line of Lot No. 53 which point is 125 feet north of the northeast corner of the intersection of Summitt Street and Henderson Street, and running thence along the east side of Henderson Street, N. 00-30 E. 75 feet to an iron pin, joint corner of Lots Nos. 54 and 55; thence along the joint line of said lots, S. 89 1/2 E. 150 feet to an iron pin; thence S. 00-30 W. 75 feet to an iron pin in the rear line of Lot No. 53; thence through the center of said Lot No. 53, N. 89 1/2 W. 150 feet to the beginning corner.
