Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of Argonne Drive in that area recently annexed to the City of Greenville in Greenville County, C. C. being shown as a part of Lots 14, 16 and 17 on plat of property of C. B. Martin made by R. E. Dalton, Engineer, February 1923 recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book F, pages 102 and 103 and having according to said plat and a recent survey made by R. W. Dalton, September 16, 1949, the following metes and bounds, to-wit:
