TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, **Greenville Home Builders, Inc.** (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **H. C. Smith and C. S. Fox**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Four Hundred Fifty and No/100**

DOLLARS (\$450.00) ,

with interest thereon from date at the rate of **Five** per centum per annum, said principal ~~and interest~~ to be repaid: **Six Months after date**, with interest thereon from date at the rate of **Five (5%)** per cent, per annum, to be computed and paid semi-annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of **Three (\$3.00)** Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as lots Nos. 12 and 13 of Block F, on plat of Stone Estates, made by C. M. Furman, Jr., October 1931, recorded in Plat Book G, at Page 292, and according to a plat made by Piedmont Engineering Service August 18, 1949, is described as follows:

"BEGINNING at an iron pin on the East side of Brookwood Drive, at joint front corner of lots Nos. 13 and 14, of Block F, and running thence along the line of lot No. 14, S. 78-38 E. 160.3 feet to iron pin; thence S. 9-30 W. 50 feet to iron pin; thence N. 78-38 W. 161.1 feet to iron pin on East side of Brookwood Drive; thence along the East side of Brookwood Drive, N. 11-22 E. 50 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by R. B. Garren by deed to be recorded herewith.

It is understood and agreed that this mortgage is junior in lien to a mortgage executed by the mortgagor to Citizens Lumber Company in the original sum of \$6000.00.
