Dollars (\$ 41.21)

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Southeast side of Bleckley Avenue in the City of Greenville, S. C., being shown as lot #15, Block "B" on the plat of Fair Heights recorded in the RMC Office for Greenville County, S. C. in Plat Book 1, page 217. said lot fronting 50 feet on the Southeast side of Bleckley Avenue and having a depth of 150 feet on the Northeast side, a depth of 150 feet on the Southwest side and being 50 feet across the rear.
