all that tract or lot of land in

Township, Greenville County, State of South Carolina.

lying and being situate at the intersection of Prancer Avenue with Panama Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot #301, Pleasant Valley, according to plat of said subdivision prepared by Dalton & Neves in April, 1946, including additions to said plat through November, 1948, as recorded in the R.M.C. Office, Greenville, South Carolina, in Plat Book "P", at Page 92, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Prancer Avenue in the Southeast corner of the intersection of Prancer Avenue with Panama Avenue; thence S. 0-08 E. 160 feet along Panama Avenue to an iron pin at the common corner of Lots #301 and #340 on the Eastern side of Panama Avenue; thence N. 89-52 E. 60 feet to an iron pin at the joint rear corner of Lots #301 and #302; thence N. 0-08 W. 160 feet to an iron pin at the joint front corner of Lots #301 and #302, on the Southern side of Prancer Avenue; thence along said Avenue S. 89-52 W. 60 feet to an iron pin in the Southeast corner of the intersection of Prancer Avenue with Panama Avenue, the point of beginning.
