C., which are shown as Nos. 105, and 79 through 88, both inclusive, as shown on plat of property of Sans Souci Development Go. made by Dulton G. Heves dated July 1930, recorded in Plat Book H at Pages 185-136 and from this plat the following description is taken:

Lot 105: Beginning at the joint corner of lets 104 and 105 on the eastern edge of W. Decatur St. and running themce along the joint line between these lots S. 64-45 E. 174.6' to their joint rear corner in line of lot 115; thence along the rear line between lots 105, 115 and 114 S. 22-30 W. 60.1' to the joint corner of lots 105 and 100 and the rear line of 114; thence along the joint line between lots 105 and 100 N. 64-45 W. 168.5' to their joint front corner on the eastern edge of W. Decatur St.; thence along the eastern edge of this street N. 10-43 E. 60.7' to the beginning corner.

Lots 79 through 88, both inclusive: Beginning at the joint corner of lots 78 and 79 on the western edge of w. Decatur St. and running thence the joint line between these lots N. 84.03 W. 138.2' to their joint rear corner; and running thence N. 11-05 W. across lots 79, 00, 61, 82, 83, 84, 85, and to a point in the line of lot 80 to a corner, a total distance of 502.4' more or less; thence running N. 25-09 E. across the remainder of lot 86 and across lots 87 and 68 to the joint
