"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Paris Mountain Township, School District 10-D, about 7 miles West of the City of Greenville, on the South side of the Buncombe Road, and having the following metes and bounds, to-wit: BEGINNING at an iron pin on the South side of the Buncombe road at the corner of property of W. T. Batson, and running thence along the South side of the Buncombe road, S. 25-47 E. 308.3 feet to an iron pin at the corner of Dean Phillips land (the iron pin is on the South side of the road); thence S. 63-35 W. 210 feet along Phillips' line to an iron pin; thence S. 26-04 E. 210 feet along Phillips' line to an iron pin at the corner of Drummond's land; thence S. 62-00 W. 258.1 feet to the center of the old Buncombe road; thence along the line of the old Buncombe road, N. 46-37 W. 101.1 feet to a point in the center of the old Buncombe road; thence N. 46-43 E. 191.8 feet to an iron pin on the line of the Jenkins property; thence N. 58-41 W. 169.9 feet to an iron pin on the line of the property of the Reedy River Church; thence N. 14-26 E. 129.4 feet to an iron pin; thence N. 34-01 E. 153.3 feet to an iron pin; thence N. 47-47 E. 215.2 feet to the beginning corner, containing 3.3 acres, more or less, and bounded on the East by the New Buncombe Road, on the South by Phillips and Drummond and on the West by the old Buncombe Road, the Jenkins land, and by lands belonging to Elizabeth Brown.
