"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick

Springs Township, near the City of Greer and West therefrom, on Carolina Avenue, known and designated as lot No. 16 on a plat of Development No. 2, Victor-Monaghan Company, a Division of J.P.
Stevens & Co., Inc., Greer Plant, prepared by Dalton & Neves, Engs., April, 1947, recorded in the R.M.C.
