organized and existing under the laws of South Carolina, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Six Thousand and No/100 - - - - Dollars (\$6000.00), with interest from date at the rate of Four & One-Half per centum (4 1/2 %) per annum until paid, said principal and interest being payable at the office of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: in Butler Township, in the City of Greenville, being shown as lot No. 9, of Block E, on Plat of Fair Heights, made by R. E. Dalton in October, 1924, recorded in Plat Book F at Page 257. Said lot has a frontage of 50 feet on the West side of Bleckley Avenue, a depth of 150 feet on the North, 150 feet on the South, and is 50 feet across the rear. Being the same property conveyed to the mortgagor by H. E. Hembree by deed recorded herewith.

ALSO, one 30-Gallon Electric Hot Water Heater and one Floor Furnace, it being the intention of the mortgagor that said chattels shall constitute a part of the real estate.
