"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being cut from lots Nos. 18, 17 and 16 of Block F, of the property of J. A. and P. F. Cureton, recorded in Flat Book I, at Page 103, and having according to survey and plat of the property of G. Herman Walker, made April 13th, 1949, recorded in Flat Book U at Page 186, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Ma le Avenue at the South-western corner of lot No. 19, and running thence with the line of lot No. 19, S. 76-06 E. 107.2 feet to an iron pin; thence N. 2-29 E. 177 feet to an iron in on the Southern side of Finehurst Drive; thence N. 88-57 A. 87.9 feet along the Southern side of Pinehurst Drive to an Iron pin; thence along the curvature of the intersection of Pinehurst Drive and Ma Le Avenue, S. 46-46 M. Mr. feet to an iron pin on Maple Avenue; thence S. 1-05 W. 125. 3 feet along Mayle Lawree to the point of beginning."
