# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, LeGrande G. Sample and Marion J. Sample  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100- - - - - DOLLARS (\$5000.00), with interest thereon from date at the rate of Five (5%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the North side of Ackley Street, near Laurens Road, and being designated as lot No. 10 on Plat of property of L. L. Bates, recorded in Plat Book H, at Page 227, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at a point on the North side of Ackley Street, which point is 514.7 feet from the intersection of Laurens Road and Ackley Street, and running thence N. 28-20 W. 241 feet to the rear corner of lot No. 5; thence with rear line of lot No. 5, 60 feet to iron pin at corner of lot No. 9; thence with line of lot No. 9, S. 28-20 E. 238.2 feet to pin on Ackley Street; thence with Ackley Street, N. 64-30 E. 60.3 feet to the point of beginning."
