

E. Colored Church, being bounded on the north and east by lands of St. Mark Church, on the south by lot No. 10 of the King Greer Estate and on the west by lot No. 12 of the King Greer Estate lands, and being shown as lot No. 11 on Plat of Property of King Greer Estate prepared by J.
