SEND GREETING:

WHEREAS, I the said Oda Armstrong

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Fourteen Hundred & eighty-nine & 00/100 (\$ 1489.00 ) Dollars, with interest from the date hereof at the rate of Seven per cent ( 7 % ) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Eighty ( \$ 80.00 ) dollars

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the East side of Albert Street in the Town of Greer, being known and designated as Lot #28 on Plat of the Marchant place, recorded in R.M.C. Office for Greenville County in Plat Bood C, page 197, and having the following courses and distances, towit:-

BEGINNING at iron pin on Albert Street, joint corner of lots #28 and #29, and runs thence N 67-19 E 159.4 feet to pin; thence N 8-09 W 32.5 feet to a stake; thence S 80-30 W 135.7 feet to pin; thence with Albert Street S 9-30 E 69 feet to the beginning corner.
