ed, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
The Peoples National Bank, Greenville, South Carolina, its successors or assigns,

all that tract or lot of land in

Township, Greenville County, State of South Carolina.

on the Northwest side of Bleckley Avenue, in the City of Greenville, known as Lot #16 and
a part of Lot #11, Block D of Fair Heights Sub-division, as per plat thereof recorded in
the R.M.C. Office for Greenville County in Plat Book F, at Page 257, and having, according
to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Bleckley Avenue at joint corner
of Lots #15 and #16 of Block D, said pin being 100 feet from the corner of Bleckley Avenue
and Decatur Street, and running thence with the line of Lot #15 N. 58-40 W. 150 feet to an
iron pin; thence continuing N. 58-40 W. 15 feet to a point in the line of Lot #11; thence
N. 31-20 E. 50 feet to a point in the line of Lot #11; thence S. 58-40 E. 15 feet to an
iron pin; thence continuing along the joint line of Lots #16 and #17 S. 58-40 E. 150 feet
to an iron pin on the Northwest side of Bleckley Avenue; thence with the Northwest side of
Bleckley Avenue S. 31-20 W. 50 feet to the beginning corner.
