at the rate of six per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and
unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder
hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be
placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the
holder thereof necessary for the protection of his interests to place and the holder should place the said note

All that piece, parcel or lot of land near the City of Greenville,
Greenville County, State of South Carolina, on the East side of E Street, in Section
No. 6 of Judson Mills Village, being known and designated as Lot No. 25 as shown on
a plat of Section No. 6 of Judson Mills Village, made by Dalton & Neves, Engineers,
November, 1941, which plat is recorded in the R. M. C. Office for Greenville County,
S. C., in Plat Book K, at Pages 106 and 107, and having, according to said plat, the
following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of E Street, joint front
corner of Lots No. 24 and 25, and running thence with the line of Lot No. 24,
N. 88-23 E. 325.7 feet to an iron pin on or near the West bank of Brushy Creek; thence
continuing with the line of Lot No. 24, N. 88-23 E. to a point in the center of Brushy
Creek; thence down Brushy Creek approximately S. 39-49 E. 89.2 feet to a point joint
rear corner of Lots No. 25 and 108; thence with the line of Lot No. 108, S. 88-23 W.
to an iron pin on or near the West bank of Brushy Creek; thence continuing with the
