with interest thereon from date at the rate of six (6%) per centum per annum, said principal ~~amount~~ to be repaid: \$30.00 December 19, 1949, and \$30.00 on the 19th day of each successive month thereafter until paid in full, with interest thereon from maturity at the rate of 6% per annum, to be computed and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, on the Northeast side of a County Road, being shown as Lot No. 4 on Plat of the Property of Central Realty Corporation, made by W. J. Riddle in October 1940, recorded in Plat Book 0 at Page 39, and containing 1.47 acres, more or less."
