in and bymycertain promissory note, in writing, of even date with these presentsamwell and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full
and just sum of FOUR THOUSAND AND NO/100 (\$4,000.00.)
Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of
FORTY AND NO/100 (\$.40.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms
of said note, and also in consideration of the further sum of Three Dollars tome, the said

situate, lying and being in the State of South Carolina, County ofGreenville,andin .Greenville Township, known and designated as Lot no. 8 and a portion of Lot No. 7 of the subdivision known as Welcome View according to a revised plat of the same, the original plat being recorded in the R. M. C. office for Greenville County in Plat book "U", at page 155, and having, according to said plat, the following metes and bounds, to-wit:
"BEGINNING at an iron pin on the East side of the White Horse Road and running thence with the White horse Road, N. 23-27 W. 89 feet to an iron pin which is 4 feet beyond the original front corner of Lots Ros. 7 and 8; thence R. 58-44 E. 222.0 feet to an iron pin, joint rear corner of Lots Ros. 7. 8. 9 and 10: thence S. 23-27 E. 82.0 feet to an iron

pin; thence S. 56-50 W. 223.0 feat to an iron pin on the East side of White Horse Road, the beginning corner and being all of Lot No. 8 and a 4-foot strip off of the southern side of Lot No. 7, including the plumbing, electrical and heating fixtures now located on said premises,

or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by N. J. Carroll by deed dated November 26, 1949, not yet recorded."
