## MORTGAGE

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the North side of Sullivan Street, and being more particularly described as follows:

"BEGINNING at a point on Sullivan Street, at a point 110 feet  $4\frac{1}{2}$  inches from the Northwest intersection of Sullivan and Augusta Streets, and running thence along Sullivan Street, S. 89 W. 79 feet  $7\frac{1}{2}$  inches to an iron pin on Sullivan Street; thence N. 12 W. 60 feet to an iron pin; thence N. 89 E. 81 feet 7 inches to an iron pin; thence S. 12 E. 60 feet to the point of beginning."
