We, Harold Jones and Ollie Belle Jones

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Seven Hundred and No/100- - - - - DOLLARS (\$ 3700.00 ), with interest thereon from date at the rate of Six (6%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, on the East side of U. S. Highway No. 29, being comprised of lot No. 5 as shown on plat of the property of G. B. Dalton and the additional triangular section purchased from J. W. Rampey and when described together has the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the East side of U.S. Highway No. 29, at joint front corner of lots Nos. 4 and 5, as shown on plat of Dalton property and running thence with line of lot No. 4, S. 65-48 E. 183.4 feet to iron pin; thence with the right-of-way of P & N Railway Company, N. 27-52 E. 112 feet to an iron pin, corner of property owned by J. W. Rampey; thence with line of said property, N. 43-27 W. 181 feet to an iron pin on right-of-way of U. S. Highway No. 29; thence with the Eastern side of said Highway, S. 31-45 W. 135 feet to the point of beginning."

Said premises being the same conveyed to mortgagors by two separate deeds recorded in Volume 364 at Page 81 and Volume 391 at Page 507.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
