WHEREAS, the Mortgagor is well and truly indebted unto

All that lot of land, together with the buildings and improvements thereon, lying and being situate on the Northern side of Prancer Avenue, within the limits of the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot # 279, Pleasant Valley, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "P", at Page 92; said Lot having a frontage of 60 feet on the Northern side of Prancer Avenue, a depth of 160 feet on the East, a depth of 160 feet on the West, and 60 feet across the rear.
