in the full and just sum of Thirty Five Thousand & No/100 (\$35,000.00) - - - - Dollars, in and by its certain promissory note in writing of even date herewith, due and payable

\$11,666.66 one year after date, \$11,666.66 two years after date. Balance due three years from date with the privilege of anticipating any part or all of any unpaid balance at any time,

with interest from date at the rate of 3 1/2% per centum per annum until paid; interest to be computed and paid annually and if unpaid when due to bear interest at same rate as principal until paid, and it has further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That , the said Greenville Airport Commission

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to it in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Southern Airways Company, a Delaware Corporation, its successors and assigns, forever:

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, on road near Lowndes Hill Road, adjoining property of Greenville Airport, containing two acres, and having the following metes and bounds, as shown on plat of property of H. C. Harvley, made by Dalton & Neves, Engineers, in August, 1939, and amended in September, 1942, to-wit:

BEGINNING at an iron pin on the west side of said road, and running thence along the said road, S. 24-07 E. 250 feet to a point on West side of said road; thence across an iron pin on the East side of said road, N. 62-22 E. 369.5 feet to an iron pin; thence N. 1-36 E. 129 feet to an iron pin in line of property of Greenville Airport; thence along line of said Airport property, N. 88-24 W. 325 feet to an iron pin; thence S. 53-08 W. 135.5 feet to the beginning corner.
