with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid quarterly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Saluda Township, Greenville County, State of South Carolina, situate on Branch of Mush Creek, waters of South Tyger River, lying on the East side of the Buncombe Road, and being the same land conveyed to me by deed from Mrs. Mamie Allen, deed dated Oct. 10th, 1944 and recorded in the R.M.C. Office in and for Greenville County in Vol. 268 at page 106, and more particularly described as follows:

Beginning at a stone and running thence S. 4 1/2 E. 10 to a stone 3X; John H. Trammell corner; thence S. 71 W. 78 to a stone corner on said Buncombe Road on said Trammell's line; thence along said road to a stone 3X (Conditional line); thence a conditional line to a stone 3X on the line first named in deed from C. Wade to S. M. Crane; thence with said line N. 87 3/4 W. to the beginning corner, containing forty-five (45) acres, more or less.
