BEGINNING at a stake on the edge of a road leading from the Haynsworth Road to the Cedar Lane Road,, at the Southwest corner of Charles M. Ballenger's land, and running thence with his line, N. 15-13 W. 750 feet to a stake; thence S. 51 W. 320 feet, more or less, to a stake, which is 27.5 feet from Farr's line; thence S. 19-16 E. 11 feet with Farr's line and 27.5 feet distant therefrom, 615 feet, more or less, to a stake on the edge of road leading from Haynsworth Road, to Cedar Lane Road, and thence with said road, N. 75-32 E. 249.7 feet to the beginning corner.
