E. Robinson, as Trustee under B. M. McGee Trust Deed, his successors and assigns, forever:

All that certain piece, parcel or lot of land near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #16 situated at the Northeast intersection of Paris Mountain Avenue and Franklin Road as shown on a plat of property of B. E. Geer made by W. M. Rast, Engineer February, 1929, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book H, Page 142, and having according to said plat and a recent survey entitled "Property of Frank L. Hughes" made by R. E. Dalton, Engineer, June, 1938, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Northeast intersection of Paris Mountain Avenue and Franklin Road and running thence along the North side of Paris Mountain Avenue, N. 84-02 E. 168 feet to a stake in a 10 foot alley; thence along the West side of said 10 foot alley, N. 6-50 W. 58.4 feet to a stake, joint rear corner of Lots #15 and 16; thence along the joint line of said lots, S. 84-02 W. 185.3 feet to a stake in the East side of Franklin Road, joint corner of Lots #15 and 16; thence along the East side of Franklin Road, S. 23-32 E. 62 feet to the point of beginning.
