Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina: on the Northeast side of Harrington Avenue, in the City of Greenville, being shown as lot No. 86 on Plat of Isaqueena Pak, made by Pickell & Pickell, on June 3, 1947, recorded in Plat Book P, at Page 130, and described as follows:

BEGINNING at a stake on the Northeastern side of Harrington Avenue, 70 feet Southeast from Oxford Street at corner of lot No. 85, and running thence with the line of said lot, N. 39-25 E. 175 feet to a stake in line of lot No. 95; thence with the line of lots Nos. 95 and 94, S. 50-35 E. 70 feet to a stake at corner of lot No. 87; thence with the line of said lot, S. 39-25 W. 175 feet to a stake on Harrington Avenue; thence with the Northeastern side of Harrington Avenue, N. 50-35 W. 70 feet to the beginning corner.
