All that lot of land, together with the buildings and improvements thereon, lying and being situate on the Northern side of Prancer Avenue, within the limits of the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot # 271, Pleasant Valley, as per plat thereof recorded in the R.M.C.
