"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as the Northern part of Lot No. 2 on Plat of property of G. Dewey Oxner, recorded in Plat Book G, at Page 42, in the R.M.C. Office for Greenville County, and having according to survey made by Pickell & Pickell, Engs., dated January 23, 1945, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the South side of Laurel Street, at corner of lot No. 1 and running thence with line of that lot, S. 33-54 W. 100 feet to an iron pin; thence S. 55-54 E. 50 feet to iron pin in line of lot No. 3; thence with line of lot No. 3, N. 33-54 E. 100 feet to iron pin on Laurel Street; thence with that street, N. 55-54 W. 50 feet to the beginning corner."
