"All ^{those} ~~that~~ certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the Eastern side of Westview Avenue, and being known and designated as Lots Nos. 8, 9 and 10 of Section B of Parkvale, a subdivision as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "K", Page 53, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Westview Avenue, joint front corner of Lot 8 and property belonging to Burgess, and running thence with Burgess's line, S. 89-30 E. 175 feet to an iron pin, joint rear corner of Lots 7 and 8; thence with the rear line of Lots 7, 6 and 5, S. 4-0 W. 225 feet to an iron pin, joint rear corner of Lots 4, 5, 10 and 11; thence S. 88-30 W. 175 feet to an iron pin on the Eastern side of Westview Avenue, joint front corner of Lots 10 and 11; thence along Westview Avenue, N. 4-0 E. 225 feet to the beginning corner.
