"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying near the

City of Greer and West therefrom, on the southwestern side of Carolina Avenue, being all of lot No. 20 in Development No. 2 as shown on a plat thereof made for Victor-Monaghan Company, Division of J. P. Stevens & Co., Inc., Greer Plant, and having the following courses and distances:
