To ALL WHOM THESE PRESENTS MAY CONCERN:

I, Robert Hoyle Snoddy of Greenville, S.C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto C. Douglas Wilson & Co.

organized and existing under the laws of South Carolina, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eighty-Two Hundred and No/100 Dollars (\$ 8200.00), with interest from date at the rate of Four & One-Half per centum (4 1/2 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S.C. or at such other place as the holder of the note may designate in writing, in monthly installments of Fifty-One and 91/100- - - - - Dollars (\$ 51.91), commencing on the first day of March , 19 50 , and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of February , 1970 .

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina: in the City of Greenville, being shown as lot No. 9 of Block K, on Plat of property of O. P. Mills made by R. E. Dalton in April 1924, and recorded in Plat Book F, at Page 171, in the R. M. C. Office for Greenville County. Said lot has a frontage of 62 feet on the Southeast side of Prentiss Avenue, a depth of 180 feet on the Northeast, 180 feet on the Southwest and is 62 feet across the rear.

Being the same property conveyed to the mortgagor by C. O. Green by deed dated May 27, 1949, recorded in Volume 382 at Page 434.

ALSO, two floor furnaces and two electric water heaters, it being the intention of the mortgagor that said chattels shall constitute a part of the real estate.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
