E. Dalton in November 1922, recorded in Plat Book F, at Page 96, and described as follows:

"BEGINNING at a stake at the Southeastern corner of Alta Vista Avenue and Eastlan Avenue and running thence with the Southern side of Eastlan Avenue, S. 54-55 E. 124 feet to a stake at corner of property now or formerly owned by W.
