Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina: in Greenville Township, on the Southeastern side of Circle Drive, near the City of Greenville, being known and designated as lot No. 13 on Plat of Franklin Heights, made by Dalton & Neves, in November 1940, recorded in Plat Book L, at Page 9, and described as follows:

BEGINING at a stake on the Eastern side of Circle Drive, 106.7 feet North from Franklin Road, at corner of lot No. 12, and running thence with the line of said lot, S. 72-23 E. 122.6 feet to a stake at corner of lot No. 14; thence with the line of said lot, N. 11-46 E. 133.6 feet to a stake on Sircle Drive; thence with the Southern side of Circle Drive, the chord of which is S. 17-30 M. 62 feet to a stake; thence continuing with the Southeastern side of said Drive, the chord of which is S. 56-26 W. 64 feet to a stake; thence continuing with the said Sircle Orive, the chord of which is S. 26-26 W. 64 feet to the beginning corner.
