To All Whom These Presents May Concern:

We, Cleveland Polson and Jessie E. Polson xxxxxxxxxxxxxxxx SEND GREETING:

WHEREAS, we the said Cleveland Polson and Jessie E. Polson in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Six Thousand and Four Hundred ----- (\$ 6400.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

One Hundred & Two & 40/100----- (\$ 102.40) dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That we the said Cleveland Polson and Jessie E. Polson, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor, in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying West of the Mosteller Road or North Main Street and on the North side of Wilson Street, near the city limits of Greer, being known and designated as Lot #1 on plat of property of Mrs. Nancy W. Finley made by H. S. Brockman, Surveyor, June 17th, 1947, and having the following courses and distances, to wit:-

BEGINNING on a stake, the Southeast corner of the lot, and in the Northwest intersecting corner of Wilson Street and the Old Mosteller Road, and runs thence with the said Old Mosteller Road N 30-30 W 163 feet to a stake, joint corner of Lots #1 and #37; thence with the dividing line of Lots #1 and #37 S 80-05 W 49 feet to a stake on the line of Lot #37 and joint corner of Lots #1 and #2; thence with the dividing line of Lots #1 and #2 S 9-55 E 150 feet to a stake on the North edge of Wilson Street; thence with the North edge of said Street N 80-05 E 112.8 feet to the beginning corner. This is the same lot of land conveyed to us by Nancy W. Finley by DEED dated May 18th, 1949.
