Dollars (\$ 6100.00), with interest from date at the rate of
four per centum (4 %) per annum until paid, said principal and interest being payable
at the office of C. Douglas Wilson & Co.

in Greenville, S. C., or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of **Thirty-two and 20/100**

Dollars (\$ 32.20), commencing on the first day of
March, 19 50, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of **February**, 19 75.

whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described

All that certain piece, parcel or lot of land with the buildings and improvements
thereon, lying and being at the Westerly corner of the intersection of Alabama
Avenue and Texas Avenue near the City of Greenville, S. C., being shown as lot #
100 on the Plat of the Talmer Cordell Subdivision recorded in the RMC Office for
Greenville County, S. C., in Plat Book "V", page 198, said lot fronting 61 feet
on the Southerly side of Alabama Avenue and having a depth of 200 feet on the
Westerly side, a depth of 200 feet on the Easterly side along Texas Avenue and
being 63 feet across the rear.
